2. **Term and Condition:**

(a) **Nature of Post.** The post is purely on temporary/contractual basis for a period of 36 Months and is not a permanent government employment. No allowance /benefits/HRA/Accommodation/Gratuity/Festival advance/advance as applicable to government appointments is applicable.

(b) **Place of work and Working hours.** Naval Dockyard Dispensary and Naval Hospital Powai Kanjurmarg Mumbai or as desired by the Administrative Authority. The working hours will be as per Naval Dockyard dispensary and Naval Hospital Powai.
